

## TradeStation Strategy Vault - NEW Strategies Installation Steps (updated 7.21.2025)

You can download the **Strategy Lab Pro - Strategy Vault - Tradestation Strategies (.zip)** file for use in Tradestation from the members area.

Please use the following steps for successfully updating Tradestation with the latest Strategy Lab Pro Strategies and Strategy Templates:

To import TradeStation ELD files, use the TradeStation Import/Export Wizard. Navigate to File > Import/Export EasyLanguage in the TradeStation desktop application, select "Import EasyLanguage file (ELD, ELS, or ELA)," and follow the prompts to locate your file and choose which items to import.

- 1) **Step 1: Open TradeStation and Access the Wizard** Launch the TradeStation Development Environment and navigate to File > Import/Export EasyLanguage.
- 2) **Step 2: Choose the Import Option** Select "Import EasyLanguage file (ELD, ELS, or ELA)" from the list of wizards and click "Next."
- 3) **Step 3: Locate the ELD File** Click "Browse" to locate and select your ELD file, then click "Open." Click "Next" to proceed.
- 4) Step 4: Select Items to Import Choose which analysis types and techniques you want to import from the file. You can select all items or choose specific ones, then click "Next."
- 5) **Step 5: Complete the Import** Click "Finish" to begin the import process. A confirmation message will appear when the import is complete.
- 6) **Step 6: Handle Overwrites (if necessary)** If prompted to overwrite existing items, it's generally recommended to keep the newer versions when importing from a different source.

ALL of these Strategies will be accessible within Tradestation in the **Studies -> Strategies** folder.
